

# SUPER SHREDDER

### PRODUCT INFORMATION + SPECIFICATIONS

#### REPLACING NYLON WHIPS

- 1 CLEAN SET SCREW HEAD WITH A PICK BEFORE LOOSENING WITH ALLEN WRENCH.
- 2 USE SUPPLIED 3/32 ALLEN WRENCH TO LOOSEN SET SCREW.
- 3 PULL NYLON WHIP OUT OF CHANNEL.
- 4 REPEAT STEPS 1 AND 2 FOR ALL 12 WHIPS.
- 5 ONCE ALL THE WHIPS ARE REMOVED, START FROM BOTTOM AND WORK OUTWARD, INSERTING NEW WHIPS INTO CHANNELS. LEAVE EQUAL SPACE BETWEEN BOTH SIDES OF BARREL.
- 6 USE ALLEN WRENCH TO TIGHTEN SET SCREW UNTIL WHIPS ARE SECURE. DO NOT OVERTIGHTEN.
- 7 REPEAT STEPS 4 AND 5 FOR REMAINING WHIPS.
- 8 TURN ON SHREDDER TO LISTEN FOR MISALIGNED WHIPS. IF YOU CAN HEAR WHIPS HITTING THE INSIDE OF THE BARREL, THEY ARE NOT ALIGNED CORRECTLY AND MUST BE RECENTERED.


#### PERFORMING REGULAR MAINTENANCE

- 1 WITH COMPRESSED AIR, BLOW OUT MOTOR DUST COVER AT THE END OF EACH SHIFT OR AT SHUTDOWN.\*
- 2 CLEAN LID WITH AN AMMONIA-FREE CLEANER.\*\*
- 3 CLEAN BARREL
  - 3A UNPLUG SHREDDER.
  - 3B REMOVE WHIPS WITH SUPPLIED 3/32 ALLEN WRENCH BY LOOSENING SET SCREWS UNTIL WHIPS PULL FREELY FROM SHAFT.
  - 3C WITH COMPRESSED AIR, BLOW OUT BARREL AND WIPE WITH A CLEAN RAG TO REMOVE REMAINING DEBRIS.
  - 3D USING ETHANOL, WIPE NYLON WHIPS, SHAFT AND INSIDE OF BARREL UNTIL NO RESIDUE REMAINS.\*\*\*
  - 3E REINSTALL NYLON WHIPS FROM BASE OF SHAFT OUTWARD USING SUPPLIED 3/32 ALLEN WRENCH.

\*NEVER PERFORM ANY MAINTENANCE ON THE EQUIPMENT UNTIL IT IS VERIFIED THAT THE SHREDDER IS DISCONNECTED FROM ITS POWER SUPPLY. ALL MAINTENANCE SHOULD BE PERFORMED BY QUALIFIED PERSONNEL ONLY.

#### **SUPPLY FORM + STORAGE**

ULTRAMID® C40 LX IS SUPPLIED PRE-DRIED AND READY FOR PROCESSING IN A VARIETY OF MOISTURE PROOF CONTAINERS, SUCH AS BOXES, BIGBAGS (ASIA) AND BULK CONTAINERS. THE MATERIAL MUST BE PROTECTED AGAINST MOISTURE DURING STORAGE. A STORAGE TIME OF 6 MONTHS SHOULD NOT BE EXCEEDED. OPENED BAGS SHOULD BE USED UP IMMEDIATELY IN ORDER TO PREVENT MOISTURE PICKUP.
